CONTRACT AGREEMENT AND RELEASE FROM LIABILITY

Please read carefully.

We at Silver Comet Cycles want your experience to be a fun and safe one. Unfortunately, cycling can be dangerous, and injury is a common occurrence. Responsible use of our equipment is important to your safety. By signing this, you agree to the following:

1. You will be the only person using the rental equipment during the rental period. You must maintain control of the rental equipment for your own safety as well as the safety of all trail users. Avoid any "trick" or "stunt" maneuvers.
2. You accept all responsibility for the care and use of the equipment. You will be responsible for the full replacement value of any equipment that is damaged or not returned. _____ (initials)
3. You will use protective equipment, **including helmet**, while using our bicycles. You take responsibility for your own physical health and condition in this activity. You assume the risk of injury or death.
4. Bikes can be used on the Silver Comet Trail, public roadways, or the location of events/races in which you are participating. Bicycles are subject to the same laws as cars and other vehicles: obey all traffic signs/signals, and stop at all traffic crossings. It is illegal to ride bicycles on sidewalks.
5. You agree to release Southeastern Path Services (doing business as Silver Comet Cycles), Cobb County, its owners, agents, and employees from any and all liability for damage and/or injury to any person or property resulting from use of this equipment. You accept full responsibility for any such damage or injury that may occur.
6. Equipment must be returned to the Silver Comet Cycles location before the end of your rental period. A fee of **\$1.00 per minute PER UNIT** will be assessed on all returns after posted closing time to a maximum of 30 minutes. After this time, the bike is converted to a 24hr rental, and the renter is responsible for returning it the next day. _____ (Initials)
7. You understand the function and use of all equipment.
